Nonfederal organizations that process, store, transmit, or provide security protection for controlled unclassified information (CUI) must adhere to NIST Special Publication (SP) 800-171 security requirements. All government contractors must be compliant within 30 days of a contract award, especially those in defense and manufacturing industries.

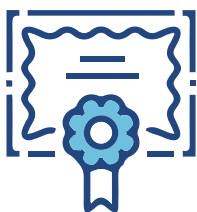
